

T-SHIRT SALES AGREEMENT

This Agreement is made between LoveShooter Inc. (“Company”) and the Partner listed below (“Partner”).

1. Purpose of Agreement

This Agreement outlines the terms under which Partner will sell “MyOfficeInTheStreets / Staying Out The Way” T-shirts on behalf of LoveShooter Inc.

2. Product & Pricing

- Retail price per T-shirt: **\$25**
- Inventory provided by Company remains the property of Company until sold.

3. Compensation

A. INDIVIDUAL PARTNER (Street Seller, Friends, Word-of-Mouth Seller)

- Individual Partner earns **\$5 per shirt sold**.
- Company receives **\$20 per shirt sold**.
- Individual Partner must return unsold shirts or pay cost equivalent.

B. STORE PARTNER (Retail Store, Boutique, Barber Shop, etc.)

- Store Partner earns **\$7 per shirt sold**.
- Company receives **\$18 per shirt sold**.
- Store agrees to display shirts in a visible, accessible area.

(If Partner is a store, Section A does not apply. If Partner is an individual, Section B does not apply.)

4. Payment Terms

- Payments are calculated at the end of each sales cycle (daily/weekly/bi-weekly).
- Partner agrees to provide accurate counts of units sold.

- Company will pick up revenue and restock as needed.

5. Inventory Responsibility

- Partner is responsible for protecting inventory from damage, loss, or theft.
- Any missing shirts must be paid for at the wholesale amount owed to Company.
- Unsold items can be returned in good condition without penalty.

6. Marketing & Promotion

- Company provides branding assets (flyers, QR codes, tags, etc.).
- Partner may promote on social media, in-store, or by word of mouth.
- Partner may not alter the product, logo, or pricing without approval.

7. No Upfront Cost

- Partner receives shirts at no upfront charge.
- Profit split happens only after successful sales.
- This program is designed for **zero-risk opportunity** for Partner.

8. Term & Termination

- Either party may end this Agreement at any time with written or verbal notice.
- Any remaining inventory or owed funds must be settled within **48 hours** of termination.

9. Liability

- Partner is not an employee of LoveShooter Inc.
- Partner acts as an independent seller/distributor.
- Partner is responsible for their own conduct while selling.

10. Agreement Acceptance

By signing below, Partner agrees to the terms listed above and acknowledges that all sales must follow the pricing and payout structure provided.
